ANNOTATION OF THE WORKING PROGRAM OF THE DISCIPLINE "PSYCHOLOGY AND PEDAGOGY OF MEDICAL ACTIVITY" Specialties 31.05.01. General Medicine

1. Goals and objectives of mastering the discipline

The goals of mastering the discipline are to form a holistic view of the general laws of the organization and functioning of the psyche, age patterns of development of a person's personality, to introduce students to the main categories of medical pedagogy.

Tasks of mastering the discipline:

- 1. Introduction to the subject of psychology and pedagogy in a historical aspect;
- **2.** Mastery by students of the categorical apparatus of general and developmental psychology, pedagogy;
- **3.** Acquaintance with the basic mental properties, processes and conditions (sensation, perception, memory, attention, thinking, speech, consciousness, will, emotions);
- **4.** Acquaintance with the basic domestic and foreign theories of personality and individuality (in the psychoanalytic, behavioral, humanistic and transpersonal direction of psychology);
- 5. Acquaintance with the basic concepts of developmental psychology, consideration of the characteristics of the mental sphere in the childhood, adolescence, mature and late period of human development;
 - **6.** Acquaintance with the pedagogical aspects of the doctor's professional activities.

2. The place of discipline in the structure of basic educational programs

The discipline "Psychology and pedagogy of medical activity" B1.B.17 refers to the basic part of the basic educational programs of higher education in the specialty 31.05.01 "General Medicine".

The discipline "Psychology and pedagogy of medical activity" is aimed at studying the basic forms of manifestation of the human psyche, the characteristics of human activity as a person, the laws of communication, interaction and management, as well as the characteristics of the processes of training and education, self-education and self-development. Knowledge, skills and abilities in the discipline occupy one of the central places in the structure of the doctor's professional culture.

To study the discipline, knowledge, skills and competencies obtained by students in a secondary educational institution and as a result of studying propaedeutic disciplines are necessary. The basic knowledge necessary for the study of discipline is formed in the humanitarian, social and economic cycle of disciplines (philosophy, bioethics).

Discipline is precedent for the further study of a number of professional disciplines.
